Affiliates	<p>Companies related by common ownership or control. They can be financial and non-financial companies.</p> <p><i>Vernon Bell has a material relationship with VAST Data Systems, Inc., a Texas corporation wholly owned by Mr. Bell, that provides technology and strategic business management services and also operates under the DBA Enterprise Benefits. Non-affiliates	<p>Companies not related by common ownership or control. They can be financial and non-financial companies.</p> <p><i>These include broker/dealers, mutual fund companies, insurance companies and other financial institutions.</i></p>
Joint marketing	<p>A formal agreement between non-affiliated financial companies that together market financial products or services to you.</p> <p><i>Texas Elite Advisory, LLC does not do joint marketing.</i></p>
